If client assets or feedback are not received in 90 days, the project will be deemed dormant. Additional Reactivation Fees may be assessed at the discretion of Quantum Dynamix, no greater than 25% of the total project costs. Monthly billing for website hosting, website maintenance, website update support, and website and database backup will begin upon website launch. Billing for email marketing will begin upon authorization of this proposal.

After an invoice is 15 days past due, the client will be subject to a 10% late fee of the original invoice amount. If the invoice is not paid in full in the next 30 days, or if a prior arrangement is agreed upon by both parties by the end of that period, access to the client's website will be revoked.
